## **FRAMING THE WEEK**

As the Biden-Harris Administration takes office this week, transforming the nation's **COVID-19 pandemic response** is one of their top priorities, along with addressing the economic downturn, the climate crisis, and systemic racism. Over his first several days in office, President-elect Joe Biden is expected to sign a series of executive orders, including a national mask mandate on federal property and during interstate travel. Biden will take additional actions to address the reopening of schools and businesses through expanded testing, worker protections, and clear public health standards.

While the Trump-Pence Administration deferred responsibility for managing COVID-19 testing and vaccination to states, the incoming administration is expected to take a more hands-on approach. To help meet their "goal of 100 million shots by the end of our first 100 days," the Biden-Harris administration will launch a **national vaccination program**, encourage states to allow more people to be vaccinated, including individuals 65 and older as well as frontline workers; and invoke the **Defense Production Act** to ensure sufficient supplies; among other actions outlined in their <u>COVID-19 vaccination plan</u>.

Securing the federal funding needed to fully operationalize such a response plan is likely to face some pushback on Capitol, as the \$400 billion proposed by Biden to address COVID-19 (including \$160 billion for the national vaccination program), is wrapped into a \$1.9 trillion package, an overall price tag that is likely too great for Republicans. Biden's <u>"America Rescue Plan,"</u> the first of a two-step legislative proposal, also includes measures to expand access to health coverage, including subsidizing COBRA coverage through September, increasing the value of advanced premium tax credits, and expanding those subsidies above the existing 400 percent of poverty threshold by capping health insurance premiums at 8.5 percent of income. Biden's ability to earn bipartisan support for his expansive rescue plan will test his deal-making skills. If those efforts fail, we expect Democrats to turn to the reconciliation process to move policies that are eligible for that mechanism forward.

- HHS announced reporting updates for the Provider Relief Fund (PRF). <u>Details</u>.
- **CMS** issued a <u>final rule</u> implementing new interoperability requirements for the exchange of patient health care data between CMS-regulated payers. <u>Details</u>.

- **CMS** released the 2022 Notice of Benefit and Payment Parameters <u>final rule</u> (<u>press release</u>; <u>fact</u> <u>sheet</u>), finalizing a subset of originally proposed policies affecting Exchanges and plans in the individual and small group markets. <u>Details</u>.
- AHRQ <u>issued</u> a request for scientific information submissions to inform its review on Interventional Treatments for Acute and Chronic Pain: Systematic Review. Submissions are due February 14. <u>Details</u>.
- **FDA** <u>announced</u> that it is permanently waiving the premarket notification requirements 7 class I devices for which the 510(k) requirements had been temporarily waived for the COVID-19 pandemic. The agency is also proposing to permanently exempt 84 additional devices from 510(k) premarket requirements and is seeking public comment on whether all or some of the devices should be exempted. Comments are due March 16. <u>Details</u>.
- **The Rural Housing Service** recently announced it is now accepting applications for fiscal year (FY) 2021 of the Community Facilities Technical Assistance and Training (TAT) Grant program. Applications are due by March 29, 2021. <u>Details</u>.
- **HHS** published a final rule (<u>press release</u>) requiring certain transparency standards when the department seeks to take civil enforcement actions against regulated parties. <u>Details</u>.
- **HRSA** recently announced a maternal and child health-focused Notice of Funding Opportunity (NOFO) Autism Secondary Data Analysis Research (SDAR) Program. Applications are due April 12, 2021. <u>Details</u>.

• **CMS** published a <u>document</u> in the Federal Register public inspection documents formally withdrawing from CMS' regulatory agenda the Medicaid Fiscal Accountability Regulation proposed rule, published on November 18, 2019. <u>Details</u>.

- **CMS** launched a new <u>web-based platform</u> for Section 1135 waiver requests (<u>press release</u>). The new platform enables streamlined documentation and centralizes requests, which CMS asserts will reduce regulatory burden and improve responsiveness. <u>Details</u>.
- ONC released the Draft United States Core Data for Interoperability Version 2 (<u>Draft USCDI</u> <u>v2</u>). The Draft USCDI v2 makes updates to the existing set of health data classes and data elements for interoperable health information exchange. Comments on the draft are due by April 15, 2021. <u>Details</u>.
- **CMS** recently issued <u>guidance</u> to state health officials designed to drive the adoption of strategies that address the social determinants of health (SDOH) in Medicaid and the Children's Health Insurance Program (CHIP). <u>Details</u>.
- **CMS** issued its final enrollment snapshot (<u>press release</u>) on ACA Marketplace sign-ups for 2021 Open Enrollment. <u>Details</u>.
