FRAMING THE WEEK

Congress remains in recess and will return next week. In the meantime, we look ahead to anticipated regulations from the Biden Administration and key comment deadlines. The fiscal year (FY) 2023 inpatient prospective payment system (IPPS) proposed rule, which has cleared review at the Office of Management and Budget (OMB), is expected imminently this week. As part of the Biden Administration's <u>initiatives</u> to address maternal health, the IPPS proposed rule will include a proposal to establish a "Birthing-Friendly" hospital designation to highlight hospitals that have participated in maternity care quality improvement collaboratives and implemented best practices that advance health care quality, safety, and equity for pregnant and postpartum patients.

Once the comment periods elapse for each FY 2023 Medicare proposed update, we can expect the final rules for each payment system to be released in August. Meanwhile, the Centers for Medicare & Medicaid Services (CMS) will work to release its proposed Medicare payment updates for the calendar year (CY) 2023 set of rules – e.g., the Physician Fee Schedule and the Hospital Outpatient Prospective Payment System, among others. Those proposed rules are expected to arrive later in June.

Beyond the proposed Medicare payment updates, a number of other notable rules are currently under review at the Office of Management and Budget (OMB), indicating the Administration is working to prepare them for release in the *Federal Register*. These rules include:

- The <u>final rule</u> for the 2023 Notice of Benefit and Payment Parameters (WHG summary on the proposed rule is available <u>here</u>);
- The <u>final rule</u> for the Contract Year 2023 Policy and Technical Changes to the Medicare Advantage and Medicare Prescription Drug Benefit Programs (WHG summary on the proposed rule is available <u>here</u>);
- A proposed rule to establish mandatory reporting requirements for the Medicaid and CHIP Core Sets (Of note, the comment period for the CMS request for information on access to care and coverage for Medicaid and CHIP closes today, April 18); and
- A proposed rule to modify the Trump Administration's changes to implementation of section 1557 of the Affordable Care Act (ACA), which curtails the scope of application of section 1557 protections and creates uncertainty and ambiguity as to what constitutes prohibited discrimination in covered health programs and activities.

Finally, several comment period deadlines end in the next few weeks, including:
